New Arrangements on Dissemination of Corporate Communications and Actionable Corporate Communications

Pursuant to the new Rule 2.07A of the Rules (the "Listing Rules") Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") under the expansion of paperless listing regime and electronic dissemination of corporate communications that has come into effect on 31 December 2023, SIM Technology Group Limited (the "Company") is writing to inform you that it will disseminate its future Corporate Communications¹ and Actionable Corporate Communications² in the manner as described in the announcement of the Company dated 9 February 2024, a summary of which is set out as below.
